CAPTIVE CUSTOMER REPRESENTATIVE FOR TPBAC SELECTION PROCESS

THE TWO (2) MEMBERS OF THE THIRD-PARTY BIDS AND AWARDS COMMITTEE (TPBAC) WHICH SHALL COME FROM THE CAPTIVE CUSTOMERS SHALL HAVE ALL THE FOLLOWING GENERAL QUALIFICATIONS:

- a) must be a Member-Consumer-Owner of NOCECO for at least three (3) years;
- b) must be residing within the NOCECO franchise area;
- c) must be of good moral character and with no record of a charge for any crime involving moral turpitude, fraud, embezzlement, theft, estafa, counterfeiting, misappropriation, forgery, bribery, false affirmation, perjury, or other fraudulent acts;
- d) is not, and has not been in the one (1) year immediately preceding the appointment, a director, officer of NOCECO, or a recipient of NOCECO retirement benefit;
- e) is not retained, either in his/her personal capacity or through a firm, as a professional adviser, auditor, consultant, agent, or counsel of NOCECO;
- f) must not have and must not be connected or affiliated with a person, firm, or entity who has an Outstanding Dispute or pending or outstanding financial obligations with NOCECO, whether civil, criminal, or administrative. Outstanding Dispute refers to any pending judicial/quasi-judicial, administrative, or alternative dispute resolution process with NOCECO;
- g) must not be a member of the TPBAC of another Distribution Utility/Electric Cooperative;
- h) must not be employed, connected, or affiliated with, or engaged by or as a third-party auctioneer under DOE Department Circular No. DC-2018-02-0003; and
- i) must not be employed, connected, or affiliated with, or engaged by an electric power industry participant (or any person or entity engaged in the generation, transmission,

distribution, or supply of electricity) for at least one (1) year immediately preceding the appointment;

SPECIFIC QUALIFICATIONS OF THE TPBAC MEMBER COMING FROM THE CAPTIVE CUSTOMERS:

A. Lawyer

- \circ be a member in good standing of the Integrated Bar of the Philippines (IBP);
- have been engaged in the practice of law for at least three (3) years; and
- have proven practice and experience in local or international competitive bidding or procurement processes, whether in the private or public sector
- familiarity and knowledge of the laws and reforms affecting the power industry, and of Power Supply Agreements and related contracts

B. Accountant with knowledge on electricity pricing

- A certified public accountant, and shall be in good standing with the Philippine Institute of Certified Public Accountants;
- have been engaged in the practice of finance or accountancy for at least three (3) years; and
- have been engaged in the practice of finance or accountancy in the electric power industry.
